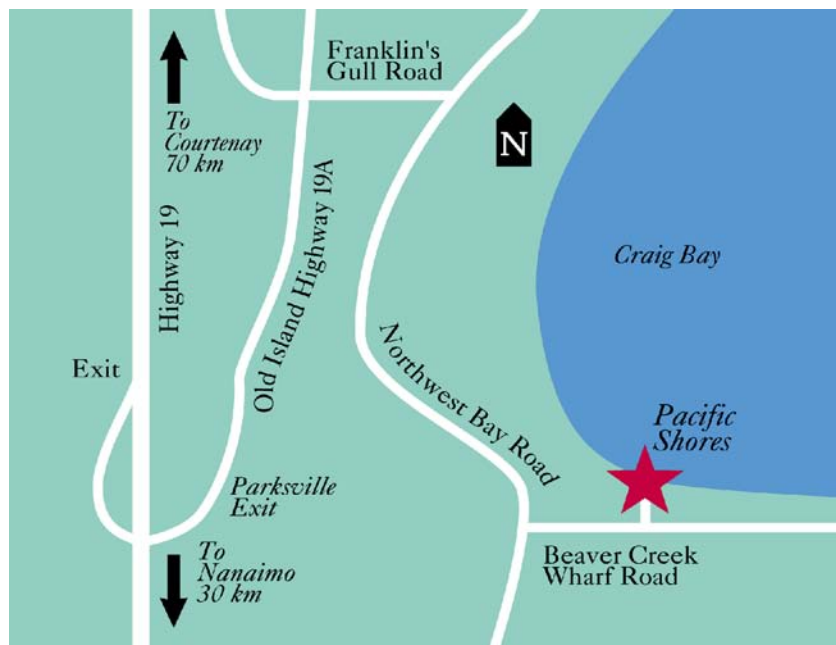

### Driving From Nanaimo

- Follow highway 19 North for approximately 30 minutes
- Take Exit 46 to Parksville (road becomes 19A)
- Look for the Visitor Information Centre on the right hand side
- Just after the Visitor Information Centre turn right onto Franklin's Gull Road
- Turn immediately right onto Northwest Bay Road
- Continue along Northwest Bay Road for approximately 1-2 minutes. Look for the large white Pacific Shores Resort & Spa sign (right side)
- Take the next left onto Beaver Creek Wharf
- Take the second left onto Strougler Road
- The road goes into the resort grounds

### Driving From Parksville

- At the intersection of Old Island Highway (19A) and Franklin's Gull Road turn left
- Turn immediately right onto Northwest Bay Road (past Visitor Information Center)
- Continue along Northwest Bay Road for approximately 1-2 minutes. Look for the large white Pacific Shores Resort & Spa sign (right side)
- Take the next left onto Beaver Creek Wharf
- Take the second left onto Strougler Road
- The road goes into the resort grounds

#### Important Booking Information for Event Guests

Reservations can be made by calling the resort directly at 1.800.500.7212.

#### Key Points to Note:

- Wedding/Event guests are subject to the same rates, booking policies, terms and conditions as regular guests. A two night minimum is required in July & August.
- The Bride and Groom will be offered a 25% discount on their wedding night only accommodations. A two night minimum is required in July & August
- In the event a guest cancels his/her booking, he/she will be subject to the standard resort cancellation penalties. Please confirm these with the Reservation Department at time of booking, penalties may vary during busier months and on holidays.
- Credit cards are required to reserve units; payment is due at time of booking.
- A valid credit card must be presented at check-in. A pre-authorization will be taken at check -in. Please note: this is an authorization and **not** an actual charge.
- Check-in time is 4pm. Check-out time is 11AM.
- Please note that the resort office is not staffed 24 hours a day. Therefore, guests arriving after 9pm must call ahead for late check-in arrangements.
- Pets are not allowed on site or in vehicles, and smoking in guest units is not permitted. Fines will be levied for breach of either rule.

### Pacific Shores Resort & Spa Terms and Conditions

#### **Alcohol Policies, Provincial Liquor Laws & Health Regulations**

All food and beverages must be supplied by Pacific Shores Resort & Spa. Wedding cakes are the exception to the rule. Vancouver Island Health Authority regulations are such that left over food may not be taken off the premises. In accordance with B.C. Liquor laws, all alcoholic beverages consumed on the premises must be purchased by the Resort through the B.C. Liquor Distribution Branch. Corkage events are respectfully declined. Pacific Shores Resort & Spa's liquor license is valid until midnight. Therefore, "last call" will be 11:30 PM and all guests are asked to vacate the premises by 12:00 AM. One set menu is required for all wedding groups. Dietary substitutions may be made by prior request. Any substitution requests made during an event are subject to a service charge. All prices are subject to change without notice, however, menu prices will be honored sixty days prior to the event date.

#### **Cancellation**

Written notification of cancellation must be received by the Sales Manager a minimum of 4 months prior to the event date, in order to receive a full deposit refund. No refund will be granted under 3 months. In the event that written notification is not received, Pacific Shores reserves the right to retain total deposit amount. Notification can be mailed, emailed or faxed.

#### **Confirmation**

A final count of attendees is due 7 days prior to the event. In the event that a guarantee count is not received, the Resort will bill the number previously discussed or the actual number attending, whichever is greater.

#### **Decorations**

The Sales Manager must be consulted regarding all displays and/or signage to be used on the property by the organizer, contractors or guests. Decorating and clean up is the responsibility of the function organizer. Use of nails, staples, glue, Scotch tape or any like materials on walls, doors, ceiling or any painted surface is strictly prohibited. Heavy fines will be levied for breach of this rule.

#### **Payment**

A non refundable deposit (**exceptions see cancellations**) of \$1000.00 is required to confirm the booking. Full payment based on the event estimate is due 14 days prior to the wedding. Authorized credit card information will be held on file to cover any costs incurred the day of the event. All cheques or payments are made payable to Pacific Shores Resort & Spa. Receipts and payment information will be mailed to event contact after event has ended.

#### **Footwear**

For the comfort of all our guests we recommend the use of proper footwear during the ceremony and dinner (both functions take place in grassy areas). Pacific Shores Resort & Spa accepts no responsibility for accidents resulting from guests who do not wear proper footwear.

#### **Personal Effects & Equipment**

All items must be removed from public areas and function rooms at the end of the scheduled event.

#### **SOCAN Fees**

Society of Composers, Authors and Music Publishers of Canada requires that the users of music obtain a SOCAN license to perform, or authorize others to perform, copyright music in public. The required license fee for an event with music will be charged based on the guidelines set out by SOCAN and the Copyright Act of Canada. This fee will be added to the bill (\$29.56 without dancing, \$59.17 with dancing).

#### **Taxes and Gratuities**

5% Federal Goods & Services Tax will be applied to all food, beverage and room rental charges. 10% Provincial Liquor Tax will also be applied to all alcoholic beverages. A 15% gratuity will be added to the final bill total. Revenue Canada rules state that gratuities are subject to GST.
